Agreement between User and www.newsgig.com

Welcome to www.newsgig.com. The www.newsgig.com website (the "Site") is comprised of various web pages operated by NewsGig ("NewsGig"). www.newsgig.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of www.newsgig.com constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

NewsGig is a content creation network and web platform allowing users to hire freelance writers and publish their content in the San Diego Union Tribune. Approved freelance writers and photographers are able to create a public profile and submit for open projects submitted by users of the platform. Examples of projects include press releases, company announcements, articles, etc. Any user can post a project by completing a form, which includes deadline date, project description and budget range. Approved freelancers are then able to submit for the project, and if chosen, are committed to completing the project. All payment and content review is facilitated within the NewsGig platform.

The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and NewsGig agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
